Welcome to the third quarter newsletter of the South Florida Chapter of the Appraisal Institute. But wait, it's only the second quarter of the year? Well now you know how I feel. The

third quarter chapter meeting is being held Friday, June 24 in Fort Lauderdale, and at this meeting we will be voting on the slate of nominees for 2023 chapter volunteers. As such, we are sending out the newsletter early to serve as notice of the meeting and 2023 nominees.

This is a renewal year for the state of Florida, and the Chapter is offering a variety of course offerings, both in-person and synchronous, to help members renew their licenses. The Chapter has 16 education offerings between now and November 10, all of which qualify for continuing education for renewal of your Florida license. August 16 is the date for our final offering of in-person 7-hour National USPAP Update, taught by Tim Andersen, MAI. The class will be immediately followed by Florida Appraisal Laws and Rules, taught by Patricia Birch. The remaining courses are offered via Livestream/Synchronous classroom, and include such offerings as Business Practices and Ethics taught by Vincent Dowling, MAI, SRA, The Paperless Real Estate Appraisal Office taught by Andy Shepard, MAI, and the 50% FEMA Rule Appraisal taught by Patricia Staebler, SRA.

Our annual South Florida Real Estate Forum, organized by Trisha Guarnieri, MAI, AI-GRS and Howard Klahr, will be held via Livestream/Synchronous classroom on July 28. Keynote speaker this year is Charlie Dougherty, Vice President and Economist for Wells Fargo Bank. The forum counts for 6 hours of continuing education toward Florida license renewal. Mr. Dougherty's presentation will provide us with a general

introduction to the basic components of economic trends to watch as it pertains to real estate markets from the macro and micro levels – national, state-wide and local to South Florida. Additional presentations and sessions will be offered.

The Leadership, Development, and Advisory Council (LDAC) was held this year, May 18 -20, in Washington, D.C. This program will address risk and the importance of equity when analyzing a property's market value. An investment risk should be addressed early in an appraisal; specifically ground work should be laid in the market analysis and emphasized in each approach developed. Under the principle of change, risk and its consideration is essential.

This program will overtly address various types of risk, expound on what is meant and offer examples for each type of risk. Risk will be discussed from the perspectives of projecting and forecasting. The program will offer guidance in generating meaningful appraisals, adhere to USPAP requirements and challenge old ways in order to achieve a better path to credible appraisal services. The goal of this program is to enhance the attendee's skills to prepare well documented and supported appraisals.

What is a Candidate Advisor?




How will the Candidate(s) I advise be chosen?

A Candidate may request a particular Advisor or the Appraisal Institute can identify a potential Advisor for the Candidate. An Advisor can decide whether to accept assignment as an Advisor for specific Candidate(s). The Appraisal Institute will make the final decision as to who will serve as an Advisor for a specific Candidate.

Candidates are reminded to ensure you are positioned to meet your annual designation requirements. Progress requirements and accomplishments may be reviewed under the Candidate's My Account tab of the Appraisal Institute website within the Candidate Status Report and Candidate Minimum Progress table.

As you may have heard, the Board approved changes to the Annual Minimum Progress requirement. Going forward, while Candidates are recommended to complete sufficient requirements per year to fulfill their timeline, they will be considered to have met Annual Minimum Progress if they have completed – or attempted to complete – at least one requirement per year.

If you have not met minimum designation progress, do not risk losing credit for the requirements previously completed. File an extension request with the Appraisal Institute at

You can also complete the *Candidate for Designation Program Extension Request* on the Appraisal Institute website in the AI Resources section under Designation Requirements Resources.

News from Al

Al Board of Directors Adopts 45-Day Notice Items During May Meeting

The Appraisal Institute Board of Directors voted to adopt four 45-Day Notice items during its May 12-13 meeting in Chicago. The 45-Day Notice items address Bylaws modernization, the Candidate for Designation program, alternate chapter representatives to regional committees and proposed amendments to the Appraisal Institute Code of Professional Ethics and Explanatory Comments to the Code of Professional Ethics.

The Board also:

- Directed to 45-Day Notice proposed amendments to Regulation No. 9 regarding eligibility to serve on regional nominating committees
 and regional nominations and elections and to direct distribution of an Exposure Draft of a proposed Regional Election Policy.
- Directed to 45-Day Notice proposed amendments to the Bylaws regarding removal of officers, directors and committee members,
 Executive Committee authority between meetings and Board ratification of Executive Committee actions.
- Referred proposed amendments to the Bylaws, Regulation No. 7, Regulation, No. 8 and Regulation No. 9 regarding eligibility for national, regional and chapter service to the Admissions and Designation Qualifications Committee for further study.
- Voted to approve the Appraisal Institute courses required to be completed in order to receive a Real Estate Analyst Professional Development Program Certificate of Completion.
- Voted to amend the Inflationary Dues Increase Policy.
- Voted to amend the Valuers Code of Professional Ethics.

Additionally, the Appraisal Institute held its Statutory Annual Membership Meeting. The next Appraisal Institute Board meeting is scheduled for August 4-5, 2022.

National Nominating Committee Nominates Paula Konikoff, JD, MAI, Al-GRS as 2023 Al Vice President

Paula K. Konikoff, JD, MAI, AI-GRS, was nominated for 2023 Appraisal Institute vice president by the Al National Nominating Committee at its May 11 meeting in Chicago.
