members. Our AI chapter, in concert with the national organization, is working hard to champion our members by providing exemplary educational offerings and representing our shared interests on the government level.

The chapter is offering one course before the April 6th Chapter Meeting and one on the same day:

Avoiding Bias: Building a Bias Defense—An Examination of Available Guidance & Requirements for Florida, taught by Nicholas Pilz, MAI, SRA, AI-RRS and Francois "Frank" Gregoire, ASA, IFA, RAA, AHW, on March 23rd; and <u>Solving Highest & Best Use</u> <u>Puzzles,</u> taught by AI President-Elect Sandra Adomatis, SRA, on April 6th

We're fortunate to be able to welcome the AI President—Elect. Don't miss Sandy's class if you can make it!

In addition, the Appraisal Institute offers countless approved continuing education courses online. Check the full schedule of virtual educational offerings and get ahead of the renewal cycle hours and while these classes are available!

Appraisal Institute Region X continues to champion for all Florida appraisers through legislative efforts. The 2023 regular legislative session runs March 7 through May 5. The big news for appraisers this season is <u>HB 213</u> / <u>SB 938</u>, <u>Limitation of Actions Involving Real Estate Appraisers and Appraisal Management</u>

<u>Companies</u>, and changes to the Statute of Repose. This will protect appraisers from frivolous lawsuits and close a loophole which allows appraisers to be sued years after they have submitted an appraisal report.

In the upcoming weeks, the bill will be heard in the <u>Judiciary</u>, <u>Civil Justice</u>, and <u>Regulatory</u> <u>Reform & Economic Development</u> Subcommittees. I urge every appraiser to contact their Legislators and inform them of the importance of this bill for appraisers, profession, consumers, and state. Frivolous and untimely lawsuits waste everyone's time and money—not just ours, but the taxpayer's as well. I have attached links to the bills as well as the committees and members. Please do not hesitate to contact me if you have any questions or suggesting regarding this.

The chapter thanks Representative David Borrero (District 111) who filed HB 213 and Senator Ana Maria Rodriguez (District 40) who filed SB 398, as well as J. Matt Terry, SRA, who has held numerous meetings with Representatives and Senators to discuss the bills and their importance. He continues pushing to ensure this important issue stays relevant to our representatives. Also, our gratitude to Carlos Gobel, SRA, who has been working behind the scenes to get these bills to the house and senate floor.

We need a call to action with all appraisers across our great state to educate our fellow constituents and our government representatives regarding how much these bills matter to everyone who uses and is impacted by appraisal services. This change will dampen frivolous and untimely lawsuits by limiting liability to something akin to record retention rules. It is a positive step forward for us, our clients and customers, and for future generations of appraisers!

BY THE NUMBERS

State of Florida, Department of Business and Professional Regulation, Division of Real Estate Licensees chart is included in this Newsletter. It shows the number of licensees before and after the renewal date in November 2022. There is a decrease in all categories. Overall, the number of licensees dropped 4.6%. The decrease in numbers for specific categories is as follows:

Certified Residential 7% - Certified Commercial 10% - Registered Trainees 16%

The shift mainly is from current to involuntary inactive.

Opinions aside, these are the facts. For a multitude of reasons, the trend is downward for the number of appraisers in Florida.

The Candidate Guidance article in this newsletter cites the change in the prerequisites to become a Candidate for Designation in the Appraisal Institute to include completing all of the education needed to earn an AI designation prior to being admitted to candidacy. This prerequisite joins one of the other prerequisites of being state certified before candidacy.

With the number of state certified appraisers decreasing, where will potential Candidates emerge? Take from the numbers what you will; they are presented for awareness. They do show the importance of maintaining Appraisal Institute designations and state certifications.



Additional nominations may be made by a timely filing of a written petition signed by at least five percent (5%) of the total number of Designated Members, Candidates, Practicing Affiliates and Affiliates in the Chapter. Such petition may be in electronic form. To be effective, each nominating petition must be delivered in writing to the Chapter Secretary at least fifteen (15) days before the regular Chapter meeting at which the election is to be held. The Chapter Secretary shall deliver in writing a copy of any petition filed to each Designated Member, Candidate, Practicing Affiliate and Affiliate belonging to the Chapter at least ten (10) days before the date on which elections are scheduled to be held. The South Florida Chapter elections will be held at the April 6, 2023 chapter membership meeting. No additional nominations can be made from the floor.

Candidate Guidance



This is a reminder of the changes to the Candidate Program effective January 1, 2023. Please note the following:

Effective January 1, 2023, any education needed to earn an Al designation (a.k.a. designation education) will no longer be a component but instead a prerequisite to the Candidate for Designation program.

As such, individuals seeking AI Designated membership who *are not already* Candidates for Designation must complete all required education to be eligible to enter the **Candidate for Designation** program. AI Admissions recommends that these individuals join AI as a Practicing Affiliate, complete all required education, then become a Candidate for Designation.

Al Admissions, with the permission of the ADQC chair, recently granted timeline extensions (12/31/2023) to Candidates whose timelines end either this year or sometime in 2023. These Candidates must complete all required education prior to the expiration of this timeline extension date (12/31/2023) to remain in the **Candidate for Designation** program.

Candidates who **do not** complete the required education (**on the most current designation path**) by this timeline extension date of 12/31/2023 may not remain Candidates, however, they may transition to the Practicing Affiliate category until they can complete the outstanding education requirements and retransition into the Candidate for Designation program. This policy also applies to Designated members earning additional designations. (Designated members would remain Designated members but would no longer be enrolled in a Candidate for Designation program.)

Individuals may retain credit for any previously completed designation requirements (if applicable) if the completion date is no older than 20 years at the time of entry into the **Candidate for Designation** program or upon approval of an additional four-year extension.

Note: Effective immediately, Annual Minimum Progress is no longer a condition of the Candidate for Designation program.

2023 Comprehensive Examination

- April 1-30 (registration deadline: March 31, recommended to apply by February 15)
- August 1-31 (registration deadline: July 31, recommended to apply by June 15)
- November 1-30 (registration deadline: October 31, recommended to apply by Sept 15)

Candidates may register through their candidate checklist. Comp Exam results are generally available about two weeks after the examination window has closed after all examinees have completed their exams.

General Demonstration of Knowledge

Please remember that the two prerequisites are <u>Advanced Market Analysis and Highest & Best Use</u> and the <u>General Demonstration Report Writing</u> seminar (within the past five years). Please note that the General Appraiser Report Writing and Case Studies course is <u>not</u> the same as the demo seminar.

New Appraisal Institute Book on Golf Property Analysis


